On the recommendations of the committee constituted for the purpose of implementation of NEP 2020/ FYUGP and in anticipation to ratification by Academic and Executive Council, the Vice Chancellor in exercise of powers vested in him under Clause 3 (5) of the Act, has accorded approval to the restructuring and renaming the existing undergraduate programmes namely, B. Sc. Actuarial & Financial Mathematics and B. A. (Hons) English to **Four Year Undergraduate Programmes (FYUGP)** in Mathematics and English, respectively.

Consequent to above, the Department of English Language & Literature and Department of Mathematical Sciences shall introduce Bachelor of Arts in English (Four Year Undergraduate Programme) and Bachelor of Science in Mathematics (Four Year Undergraduate Programme), respectively, from the academic session 2022. The existing programmes namely, B. Sc. Actuarial & Financial Mathematics and B. A. (Hons) English shall be discontinued from academic session 2022. The intake capacity and fee structure shall however remain unchanged.

The Heads of concerned Departments shall accordingly submit an updated detailed course structure and syllabus as per NEP 2020/ FYUGP Guidelines.

On the recommendations of the Committee constituted for the purpose Vide No. IUST/DAA-Acad/22/970 dated: 03-06-2022 and in anticipation to the ratification by Academic/ Executive Council, the Vice Chancellor in exercise of powers vested in him under Clause 3 (5) of the Act has accorded approval to the "Policy for Distribution of Seats" as per new reservation breakup for admissions (followed in pursuance to the Govt. of Jammu & Kashmir (UT) notified Vide No. S.O 127 dated: 20-04-2020) as detailed under:

- a) A seat matrix detailing the weightage attached to each category as per the reservation policy shall be prepared.
- b) At the first instance, seat(s) shall be allotted as per the whole number attached to each category. Fractional part attached to each category shall be ignored here.
- c) In case the fractional part attached to the open merit quota and/or to any other reserved category is  $\geq 0.5$ , one full seat shall be allotted to that particular category subject to the condition that the allotted seats do not exceed the intake capacity. In that case, the seat(s) shall be allotted by clubbing together the category/ies having fractional part  $\geq 0.5$  and the seat shall be allotted to the category/ies as per the relative merit position of candidates competing for admission against these categories, followed by the remaining category/ies having 2<sup>nd</sup> relative merit position of candidates competing for admission against these categories and so on. All such seats are subject to the condition that not more than one seat is allotted to a fraction attached to the particular category.
- d) In case seat (s) remain vacant after allotting the seats as per b) and c) above, such vacant seats shall be allotted by clubbing together the category/ies having fractional part  $< 0.5$  who have not been allotted seat(s) and the seat shall be allotted to the category/ies as per the relative merit position of candidates competing for admission against these categories, followed by the remaining category/ies having 2<sup>nd</sup> relative merit position of candidates competing for admission against these categories and so on. All such seats are subject to the condition that not more than one seat is allotted to a fraction attached to the particular category.
- e) In case there is non-availability of candidate(s) to fill seats under a particular reserved/ Self-Financing category, such seat(s) shall be shifted to open merit quota.

**Note:** If a candidate's merit (selected under reserved category) falls under the open merit category, the selection of the candidate /s shall automatically be considered under open merit.

In anticipation to the ratification by Academic/ Executive Council, the Vice Chancellor in exercise of powers vested in him under Clause 3 (5) of the Act has accorded approval to the adoption of AICTE Circular dated: 07-03-2022 and AICTE Approval Handbook 2022-23 regarding eligibility for admission to various B. Tech. / Diploma Engineering (Lateral Entry) programmes, respectively, as detailed under:

Eligibility	
<b>B. Tech. Engineering (Lateral Entry)</b>	Passed Minimum 3 years / 2 years (Lateral Entry) Diploma examination with at least 45% marks (40% marks in case of candidates belonging to reserved category SC/ST) in ANY BRANCH of Engineering and Technology. <b>OR</b> Passed B.Sc. Degree from a recognized University as defined by UGC, with at least 45% marks (40% marks in case of candidates belonging to reserved category SC/ST) and passed 10+2 examination with Mathematics as a subject. <b>OR</b> Passed D.Voc. Stream in the same or allied sector. (The University shall offer suitable bridge courses such as Mathematics, physics, Engineering drawing, etc., for the students coming from diverse backgrounds to achieve desired-learning outcomes of the programme). Note: B.Voc. course is treated at par with Diploma in Engineering and B. Sc. Degree for the purpose of admission in B. Tech./BE Programme through Lateral Entry.
<b>Diploma Engineering (Lateral Entry)</b>	10 <sup>th</sup> + (2 years ITI) shall be eligible for admission to Second Year Diploma Course(s) in ANY branch of Engineering and Technology. (The University shall offer suitable bridge courses such as Mathematics, Physics, Engineering drawing, etc., for the students coming from diverse backgrounds to achieve desired learning outcomes of the programme) <b>OR</b> Passed 10+2 examination with any of the three subjects (Physics/ Mathematics / Chemistry/ Computer Science/ Electronics/ Information Technology/ Biology/ Informatics Practices/ Biotechnology/ Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/ Entrepreneurship).

Furthermore, the online application form fee shall be Rs. 500/-. In case candidates apply for more than one programme, they shall have to pay an additional fee of Rs. 200/- (per programme) as application form fee. However, the fee for applying under self-financing and NRI shall remain same as already in vogue. There shall be separate entrance test(s) for MCA and M.Sc. IT programmes w.e.f. academic session 2022 and onwards.



- **IUST INTERNAL QUOTA (IQ):** 02 seats in all the Postgraduate programmes and 03 seats in B.Tech. Engineering (Lateral Entry) programmes shall be reserved for the candidates who have passed their qualifying degrees from IUST.
- **IUST Employee Quota (EQ):** 01 seat in each programme (except for Basic B.Sc. Nursing and B. Arch), shall be reserved for the children of permanent Employees of IUST.
- **Non-Resident Indian Sponsored Quota (NRI):** Seats under NRI Sponsored Quota shall be Supernumerary in nature except for B.Tech. Engineering and other AICTE approved programmes.
