The Member Secretary welcomed the Chairman and the Board members to the BORS meeting. Prof. Abdul Salam Bhat, Dean School of Humanities & Social Sciences formally welcomed the Board members and emphasized the importance of the Board of Research Studies meetings in promoting meaningful research, After the formal welcome address Prof. Mushtaq Ahmad Qurishi, Dean Academic Affairs addressed the Board members and said that IUST is committed to excellence in the area of research. Hon'ble Vice Chancellor Prof. Mushtaq Ahmad Siddiqi, in his address to the Board members highlighted the importance of Research in the academic growth of a University. He said that IUST is committed to provide an intellectually stimulating environment to its scholars. He also emphasized that IUST will encourage quality research so that researchers inculcate critical thinking and scholarly acumen. He appreciated the Board members for sharing their expertise with IUST faculty and looked forward to such cooperation in the future board meetings as well.

Thereafter the agenda items were taken up for discussion and the following decisions were taken.

### Department of Arabic Language & Literature:

The board members reviewed the PhD synopsis (recommended by DRC) of the scholars pursuing Integrated M.Phil-PhD Programme in the department and the following were resolved:

- 1) The board made changes in the titles of the PhD synopsis of two research scholars namely Peerzada Bilal Ahmad Shah and Waseem Hassan Raja.
- 2) It was also decided that in future there must be a compact translation of the Arabic synopsis in English so that all the board members can comprehend the proposed research topics.
- 3) It was decided that in future, all the supervisors will have to be present in the BORS meetings to defend the synopsis of their scholars.

- 6) The following Changes/modifications were suggested for all the five synopses:
- a) In the Review of Literature, the scholars should not write the details of the book other than author and title as the detail is generally written in the bibliography. The Review of Literature must be written in continuity rather than in Paragraphs. The Review should also include the theme and methodology of writer.
- b) Research Methodology should be more explicit and detailed
- c) The Chapterization should be changed in accordance with the new title, wherever the changes/modification are adopted.

- d) Original sources, primary sources and secondary sources should be identified separately.
- e) Same style of bibliography should be adopted in all the synopsis.
- f) The synopses have to be submitted again to DRC/BORS (including external expert Prof. Naseem Ahmad Shah) for approval.

Decisions regarding acceptance/ rejection/modification of synopses submitted by the scholars of the School was the main item of the agenda. Other items included extension in the time period to complete PhD degree, recognition of faculty members as supervisors and endorsement of various special decisions already taken by the Vice Chancellor under abnormal conditions routed in prolonged hartals/covid-19 lockdown.

Exact changes in case of each synopsis will be available only on 28-10-2020 when the "action taken report" is received from the concerned HODs who have been requested to submit the same latest by 27-10-2020 (letter enclosed)

Since the agenda was presented department wise rather than item wise, the minutes of the meeting given below are also summarize department wise:

#### Department of Arabic Language & literature:

- i) Eight synopses were presented for discussion same were approved with minor/major changes/modifications particularly with respect to the title of the synopsis. In certain cases, such changes are likely to warrant revision in the statement of the problem, objectives, research questions and methodology to be followed by the scholar. Due to our utter lack of knowledge with respect to Arabic language we can't reflect the exact changes in case of any synopses as recommended by BORS. However, once the 'action taken report' is received from HOD Arabic Language and Literature, same will be appended with these minutes.
- ii) BORS considered the request of one scholar namely Peerzada Bilal Ahmad Shah registration No: IUST/ARB/MPhil-PhD/FT/01 regarding extension in the time period to submit his thesis which he could not do during due course of time owing to coid-19 related lockdown. Request was found genuine and extension grated in favour of the candidate by a period of six months from 13-10-2020

#### Department of English Language & Literature:

The synopsis submitted by Umair Hyder was approved by BORS with the following modification:

- i) The title of the synopsis was changed from "9/11 and Counter -Discourse: A Critical Study of Select Novels" to " 9/11 Discourse and Counter -Discourse: A Critical Study of Select Novels".
- iii) The title of the first chapter was changed from "Discourse and Counter Discourse: An Overview" to "9/11 Discourse and Counter Discourse: An Overview"
- ii) BORS considered the request of one scholar namely Misba Majeed registration No: IUST/ENG/MPhil-PhD/14/01 regarding extension in the time period to submit her thesis which she could not do due to political disturbances/lockdown since August 2019. As in case of the department of Arabic, extension was granted in favour of the candidate by a period of six months from 13-10-2020.

#### **Department of Islamic Studies:**

Eight synopses submitted by Department of Islamic Studies were presented out of which seven were accepted with various changes/improvements while as one synopsis was referred back to the department for revision. Modifications in the title of the synopsis can have repercussion on research questions/objectives/chaptalization etc which have to be taken into account. The changes recommended in case of each synopsis are mentioned as under:

- The title of first synopsis submitted by Raba Siddiq was changed from "The Contribution of Talal Asad and Saba Mahmood to the Development of Islamic Anthropology" to "Anthropological dimensions in the Islamic thought of Talat Asad and Saba Mehmood a Study"
- ii) The second synopsis submitted by Bilal Ahmad Bhat was approved with the suggestion that grammatical mistakes be removed from the title of the synopsis.
- iii) The third synopsis submitted by Athar Shahbaz Wani entitled "Islamic Banking and Finance in India: Prospects and Impediments" was approved with the suggestion that introduction need to be enriched by taking help from review of literature segment of the synopsis.
- The fourth synopsis submitted by Javeed Ahmad Malik entitled "Contribution of 'Allāmah Shibli Nu'māni and Mawlāna Idrīs Kandhalwi to Urdu Sīrah Writing: A Comparative Study" was replaced by "Urdu Sīrah Writing in India A Study of Allāmah Shibli Nu'māni and Mawlāna Idrīs Kandhalwi" and introduction need to be enriched by taking help from review of literature segment.
  - b) Research questions posed in the present form need to be redrafted and expressed in explicit form.
- v) The fifth synopsis submitted by Gawhar Ahmad Khan entitled "Protection of Civilians during Conflict: A Comparison between Islamic Law and International Humanitarian Law" was replaced by "Protection of Civilians during Conflict: A Comparison between Islamic and International Law".
- vi) The sixth synopsis submitted by Gulzar Ahmad Bhat entitled "Contemporary Muslim Scholars' Approach to Human Rights in Islam: A Study of Dr. Mohammad Fathi Osman" was approved.
- vii) The seventh synopsis submitted by Shabir Ahmad Magray entitled "Diplomacy in Islam: A Historical Perspective (711-1258)" was not approved and was referred back to the department for thorough revision.
- viii) The eighth synopsis submitted by Ishrat Nabi entitled "Muslim Women's Approach to the Quranic Studies: A Study of Amina Wadud and Asma Barlas" was replaced by "Muslim Women scholar's Approach to Quranic Studies in modern times: A Study of Amina Wadud and Asma Barlas"

2.Extension request which was already approved by the Vice Chancellor using his special powers in case of five scholars of the Department for completion of their PhD degree was considered by the BORS. The Vice Chancellor's decision was endorsed and an extension by a period of six months from 13-10-2020 was granted in favour of the following five scholars:

- i. Submission of M.Phil Dissertation.
- ii) conduct of Viva-voce &
- iii) decleration of result.

# Department of Journalism & Mass Communication:

- 1. The synopsis submitted by Syed Aadil Hussain was approved by the BORS subject to inclusion of following suggestions made by Dr. Shahid Rasool, expert of the discipline who could not attend the meeting in person but submitted a detailed report covering all the aspects of the synopsis.
- 1. The researcher needs to properly identify some of the New Media Technologies and discuss how they have been used by various print media agencies particularly the English Newspapers in India and specifically in a Kashmir.

2. The topic must also be examined in the light of Media Convergence Theory. The theory provides, how technologies help in merging of various communication platforms into one single platform that guides collection, production, distribution, and consumption of media contents through various channels such as mobile phones, digital TV, Notepads and the Internet.

3. The sample size of the respondents for interviews need to be increased to at least 10

each category for better understanding of the issue.

4. The sample size of 20-25 for Case Study may be difficult to handle for in-depth study. The researcher may bring it down to 10-12 Newspapers. For reference point he may take 1-2 leading English Newspapers of the valley.

5. The researcher may also need to understand it from the perspective of newspaper readers, especially the new generation, the 'digital natives'. Therefore the researcher may consider conducting an empirical research with a sample of around

100-150 UG/PG students.

6. The literature review may also include "Old Media New Media" by Wilson P Dizard Jr. This book provides insights into how old media survives or reinvents itself when the new media arrives. He must also go through the "World is Flat" and "Thank you for being Late" by Thomas Friedman.

7. The researcher may also add one full chapter on technological revolution and

innovations sweeping the media landscape and the opportunities.

2. Dr. Rabia Noor and Monisa Qadri have been recognized as research supervisors subject to the fulfilment of eligibility criteria to be verified and submitted by the concerned HOD to the Office of the Dean Research.

3. Syllabus for PhD course is also approved with the addition of one more chapter entitled 'Media Research -need assessment, formative and summative research, audience research, TRPs etc. be included towards the end of the first unit.

#### Rinchen Shah Centre for West Himalayan Cultures:

1. Two synopses were presented for discussion viz "Religious Extremism In South Asia: A Case Study of Jammu And Kashmir" and "Rehabilitation and reintegration policies for former militants: A Comparative study of Jammu and Kashmir and Nagaland? The first synopsis was considered as highly sensitive. After lot of discussion it was finally decided that a sub-committee of the following members will meet again on 28-10-2020 to finalize the synopses of the Centre.

#### **BORS Decision:**

BORS also took following decisions which every department within the School has to implement:

- i. UGC directive regarding two credit compulsory course entitled 'Research and Publication Ethics (RPE)' for each scholar pursuing PhD programme was considered by the BORS and it was decided that Dean Research shall constitute a committee under his chairmanship to find ways and means for implementation of this UGC directive.
- ii. While as tentative bibliography is permissible, there is no scope for tentative bibliography which has to be avoided.
- iii. Each school shall have a common paper on research Methodology wherever possible. In case of School of Humanities & Social Sciences there shall be two such papers one covering Languages (Arabic and English) and other Social Sciences (Journalism, Islamic Studies and Centre for International Relations).
- iv. From the next BORS every synopsis from each department of the School shall contain a single page summary statement of the synopsis highlighting statement of the problem objectives, Research Questions, Methodology and chapterization
