Applications through online mode are invited from eligible candidates for engagement **Assistant Professors** on contractual basis as academic arrangement in the Centre for Vocational Studies as shown below:

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

### II. Tenure

The tenure of contract shall be 01 Year (extendable upto 03 years based on the performance/ feedback etc. after each year) or till the post is filled on permanent basis whichever is earlier.

# III. Leave

As per University norms applicable to contractual employees.

# IV. How to Apply:

The eligible candidate shall apply online and then submit the downloaded application form alongwith fee receipt of Rs 300/deposited at JK Bank IUST Campus and supported by attested copies of all relevant documents, certificates, and testimonials in the office of Dean School of Health Sciences, IUST on any working day by or before the last date (except Saturday and Sunday) for submission of hardcopies, failing which the online application form submitted by the candidates shall not be considered.

### V. Selection process:

The selection of a candidate shall be based on academic merit calculated as per UGC regulations 2018 (Table:3. A) and interview in ratio of 50:50. In case, the number of applications is more, the interview shall precede by shortlisting which shall be done on the basis of academic merit calculated as above. For one vacancy 20 candidates and for every subsequent vacancy 5 additional candidates shall be short listed for interview.

### VII. Important Notes:

- 1. The applications shall have to be submitted through the University portal <u>www.iust.ac.in</u> under the specified tab.
- 2. Candidates will have to produce original documents relating to their qualification, experience etc. at the time of appearing in the interview.
- 3. No TA/DA shall be paid to candidates for appearing in the interview.
- 4. Only post qualification experience shall be considered.
- 5. Eligible candidates will be informed about the date and place of interview through University website / e- mail/ whichever suitable. However, University does not take any responsibility for non-receipt or delayed receipt of the intimation by a candidate.
- 6. Candidates who have been awarded postgraduate/Ph. D degree from Foreign University should enclose Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered, and application form will be rejected.
