II. Tenure

The tenure of contract shall be 01 Year (extendable upto December, 2025) based on the performance/ feedback etc. after each year) or till the post is filled on permanent basis whichever is earlier.

The eligible candidate can apply online and deposit fee of Rs. 300/- online and submit the downloaded application form and supported by attested copies of all relevant documents, certificates, and testimonials in the **Concerned Centre / Department of IUST** on any working day by or before the last date (except Saturday and Sunday) for submission of hardcopies, failing which the online application form submitted by the candidates shall not be considered.

V. Selection process:

The selection of a candidate shall be based on academic merit calculated as per UGC regulations 2018 (Table:3. A) and interview in ratio of 50:50. In case, the number of applications is more, the interview shall precede by shortlisting which shall be done on the basis of academic merit calculated as above. For one vacancy 20 candidates and for every subsequent vacancy 5 additional candidates shall be short listed for interview.
