
I am directed to state that the Executive Committee of the Council of Architecture (COA) considered the appeal submitted by the institution against the decision of the Executive Committee rejecting its application for introduction of 5-year B.Arch. degree course, together with the information provided by the institution, for introduction of **5 year full-time Bachelor of Architecture (B.Arch.) degree course** at your proposed institution - School of Architecture, Islamic University of Science & Technology, University Avenue Awantipora, Pulwama, Jammu & Kashmir from the Academic Session 2020-2021.

The Executive Committee also perused the inspection report of the Inspection Committee which conducted online inspection of the institution on 28.10.2020, based on the Council of Architecture (Minimum Standards of Architectural Education) Regulations, 1983.

Accordingly, the Executive Committee, based on the documents submitted by the institution and the recommendations of the Inspection Committee, is pleased to accord approval to the Institution for introduction of **5-year full-time Bachelor of Architecture (B.Arch.) degree course** as under:

The following observations of the Executive Committee are mentioned below for your information and compliance:

- The institution and university must recruit adequate cadre-wise faculty as per COA Norms before the commencement of B.Arch. course for the academic session 2020-2021.

The institution shall be required to appoint adequate cadre-wise Faculty of Architecture and also maintain Physical & Academic infrastructure & facilities, as per the Council Norms for the academic session 2020-2021. The institution shall also appoint faculty to fill up any vacancy, as may occur, within 15 days of such vacancy.

The Council reserves the right to carry out surprise inspection of institution at any point of time in order to verify the faculty and physical & academic infrastructure and facilities shown by the institution during online inspection and also to verify the compliance made by the institution in order to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council. **In case any discrepancy in regard to the information supplied/shown by the institution or non-compliance of the Council Norms is found at any stage, strict penal action shall be initiated by the Council against the institution including withdrawal of approval, closure of institution and/or transfer of existing students to other institutions.**
