IUST has also adopted Tuition Fee Waiver Scheme as per the AICTE guidelines which have benefited many students from different programmes till 2020, which was granted to poor and meritorious students. Scheme is applicable to all programmes offered by university.</p> <p>Requirements / Eligibility / Admission Procedure</p> <ul style="list-style-type: none">➤ The candidates whose parental annual income will be less than ₹. 8.0 lakhs from all sources shall only be eligible to apply under this scheme. In this regard a certificate as per the University format needs to be produced by the student from the concerned Tehsildar at the time of submission of the application form.➤ The waiver is limited to the tuition fee only. All other fees except tuition fee will have to be paid by the beneficiary.➤ In the event of non-availability of the students in this category the same shall not be allotted to any other category of applicants.➤ The University shall make a separate merit list for this category and effect admissions on the basis of the general merit list so generated.➤ Only one candidate from a particular family shall be eligible to avail the benefit of Tuition Fee Waiver Scheme.➤ The selection under TFW scheme shall be based on the total merit obtained by the student at the time of his/her admission and the income specified above.➤ Students admitted under this scheme shall not be allowed to change Institution/Course/Branch under any circumstances.➤ A letter in this respect shall be issued by the University for admission to each beneficiary student admitted under this scheme	<p>http://iust.ac.in/</p>
