As recommended by Academic Council in its fourth meeting held on 5th February, 2018 and approved by the Executive Council in its eighth meeting held on 24th March, 2018, every department of Studies in the University shall have a Board consisting of the following members :-

- (i) The Dean of the School; (Chairman)
- (ii) The Head of the Concerned Department; (Convener)
- (iii) Professors and Associate Professors of the Department;
- (iv) Two Assistant Professor by rotation on seniority basis;
- (v) Two members nominated by the Academic Council for their special knowledge in the concerned subject; and
- (vi) Such other members, but not exceeding five, as may be specified in the Ordinance.

The members at S. No. iv, v & vi shall have a term of three years and shall be eligible for re-appointment. Further, majority of the members shall form the quorum.
