Such candidates are informed to note about the allotment of their upgraded branches for future references.

The candidates having **DOUBLE ASTERISK MARK (**)** superscribed on their form numbers are advised to report in writing to Assistant Registrar Admissions for the final allocation of their branches on any working day **from 2nd to 8th September, 2015** failing which the candidates shall be considered in the already registered branch.
