In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit and preference.
3. In case of any available vacancy (ies) after **07-10-2022**, further upgradation of course shall be done in the subsequent Selection Notifications based on merit & preference amongst the **ALREADY ADMITTED CANDIDATES ONLY.**

The candidates having **SINGLE ASTERISK MARK (*)** superscribed on their Form Numbers are already admitted candidates and they have been automatically upgraded from one course to another in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded course for future references.
5. The candidates having **DOUBLE ASTERISK MARK (**)** superscribed on their Form Numbers have been upgraded from reserved category to OM in the already allotted course in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
