The candidates having **SINGLE ASTERISK MARK (*)** superscribed on their Form Numbers are already admitted candidates and they have been automatically upgraded from one course to another in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded course for future references.
4. The candidate having **DOUBLE ASTERISK MARK (**)** superscribed on his/her Form Number is upgraded from reserved category to OM in the already allotted course in view of his/her merit and preference. The candidate is informed to note about the allotment of his/her upgraded category for future reference.
5. The candidate having **HASH MARK (#)** superscribed on his/her Form Number is already admitted candidate in SF category and is now selected in OM category in another course as per his/her merit and preference. The candidates is advised to report in writing to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **15-09-2023** for the final allocation of his/her course, failing which he/she shall be considered in the already registered/ admitted course.
