In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit and preference.

The candidates having **SINGLE ASTERISK MARK (*)** superscribed on their Form Numbers are already admitted candidates and they have been automatically upgraded from one course to another in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded course for future references.
4. The candidate having **DOUBLE ASTERISK MARK (**)** superscribed on his/her Form Number is upgraded from reserved category to OM in the already allotted course in view of his/her merit and preference. The candidate is informed to note about the allotment of his/her upgraded category for future reference.
5. The candidate having **TRIPLE ASTERISK MARK (***)** superscribed on his/her Form Number is already admitted candidate in SF category and is now selected in OM category in the already allotted course as per his/her merit and preference. The candidate is informed to note about the allotment of his/her upgraded category for future reference.
6. The candidates having **HASH MARK (#)** superscribed on their Form Numbers are already admitted candidates in SF category and are now selected in General category in another course as per their merit and preference. The candidates are advised to report in writing to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **20-09-2023** for the final allocation of their course, failing which they shall be considered in the already registered/ admitted course.
