Such candidates are informed to note about the allotment of their upgraded course for future references.

The candidates having **DOUBLE ASTERISK MARK (**)** superscribed on their Form Numbers have been upgraded from reserved category to OM in the already allotted course in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
5. The candidate having **HASH MARK (#)** superscribed on his/her Form Number is already admitted candidate in SF category and is now selected in General category in another course as per his/her merit and preference. The candidate is advised to report in writing to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **09-08-2024** for the final allocation of his/her course, failing which he/she shall be considered in the already registered/ admitted course.
