In case any candidate fails to report within the stipulated time, the seat shall be allotted to the next candidate in order of merit.

ADMISSION UNDER SELF FINANCING CATEGORY / NRI SPONSORED QUOTA:

FOR SELF-FINANCING CATEGORY: The eligible candidate(s) whose name is shown in the Merit Lists and are desirous to apply under **Self Financing Category** may apply online by clicking on the tab (**Apply for SF Seat**) in the admission login page on the university website www.iust.ac.in and deposit fee of Rs. 500/- (non-refundable) online by or before **19-08-2024**. They need not to submit the hard copies of the Self-Financing Application Form at this point of time, however, the downloaded application form may be required later for admission purposes if the candidate is selected. The candidates who shall apply online under Self-Financing category and fail to deposit the requisite fee shall not be considered under this category.

FOR NRI SPONSORED QUOTA: The candidates who have not applied earlier &/or have not appeared in the CUET can also apply under this quota and shall have to submit an application in the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **19-08-2024** (except on Saturday & Sunday) alongwith application fee of Rs. 500/- and copy (ies) of required NRI Sponsored documents as mentioned in the University Prospectus 2024. The selection under this quota shall be based on the 12th percentage.
