The candidates having **TRIPLE ASTERISK MARK (\*\*\*)** superscribed on their Form Numbers have been upgraded from Self-Finance to General category in the already allotted College in view of their merit and preference. Such candidates are informed to collect the upgradation letter of General category for future references and refund of fee (if any).
- **4.** The candidates having **HASH MARK** (#) superscribed on their Form Numbers are already admitted candidates in AMCN&MT under General category and have been now selected in SMMCN&MT under Self-Finance category as per their merit and preference, such candidates are advised to report to the Office of the Dean Academic Affairs, IUST Campus Awantipora on **28-10-2024** for the final allocation of their college, failing which they shall be considered in the already registered/ admitted college.
- 5. The provisional admission shall be confirmed after the final verification of eligibility etc. by J&K Paramedical Council. If upon verification any candidate is found ineligible his/her admission shall be cancelled ab-initio.
- 6. In case any candidate fails to complete the admission formalities whether selected in General or SF category in any of the mentioned College/ Programme, they shall not be considered for further selection/ upgradation of seat/ college etc. and their seat shall be allotted to the next candidate in order of merit and preference.
