2. Provisionally selected candidates must report to the **Office of the Dean Academic Affairs, IUST Campus Awantipora** on any working day by or before **31-07-2025 (except on Saturday & Sunday)**.
3. Carry downloaded application form, original documents (along with photocopies), and the required fee as specified in the Admission Guidelines on the University website. Failure to report by the deadline shall lead to forfeiture of the admission claim.
4. The candidates having **SINGLE ASTERISK MARK (\*)** superscribed on their Form Numbers are already admitted candidates and they have been automatically upgraded to another branch/ programme in view of their merit and preference, such candidates need not to visit the university again and are informed to note about the allotment of their upgraded branch/ programme for future references.
5. The candidates having **DOUBLE ASTERISK MARK (\*\*)** superscribed on their Form Numbers have been upgraded from reserved category to OM in the already allotted branch/ programme in view of their merit and preference, such candidates need not to visit the university again and are informed to note about the allotment of their upgraded category for future references.
6. The candidates having **TRIPLE ASTERISK MARK (\*\*\*)** superscribed on their Form Numbers have been upgraded from Self-Finance to General in the already allotted branch/ programme in view of their merit and preference. Such candidates are informed to note about the allotment of their upgraded category for future references.
7. The candidates having **HASH MARK (#)** superscribed on their Form Numbers are already admitted candidates in general category in one branch and have been now selected in Self-Finance category in another branch as per their merit and preference, such candidates are advised to report to the Office of the Dean Academic Affairs, IUST Campus Awantipora on any working day by or before **31-07-2025** for the final allocation of their branches, failing which they shall be considered in the already registered/ admitted branch.
8. **The candidates whose result of their qualifying examination (final year) is yet to be declared and are selected in the above-mentioned programmes shall have to submit an affidavit from 1<sup>st</sup> Class Magistrate mentioning that he/she will make good the deficiency within a fixed period of time determined by University, failing which their admission shall be cancelled.**
9. In case of any available vacancy (ies) after **31-07-2025**, further upgradation of course (wherever applicable) shall be done in the subsequent Selection Notifications based on merit & preference amongst the **ALREADY ADMITTED CANDIDATES ONLY**.
