B. Sc. Artificial Intelligence	<i>Having passed 10+2 with a minimum of 50% marks from the J&K Board of School Education or from any other recognized board.</i>
B. Sc. Data Science	<i>Having passed 10+2 with a minimum of 50% marks from the J&K Board of School Education or from any other recognized board.</i>
B.Sc. Computer Science	<i>Having passed 10+2 with a minimum of 50% marks from the J&K Board of School Education or from any other recognized board.</i>
B. Sc. Geospatial Technologies	<i>Having passed 10+2 science subjects with a minimum of 50% marks from the JKBOSE or from any other recognized board.</i>
B. Sc. Environmental Science	<i>Having passed 10+2 science subjects with a minimum of 50% marks from JKBOSE or from any other recognized board.</i>
B. Sc. Mathematical Sciences	<i>Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board.</i>
B. Sc. Physics	<i>Having passed 10+2 with a minimum of 50% marks with Physics as one of the subject from JKBOSE/ any other recognized board.</i>
B. Sc. Chemistry	<i>Having passed 10+2 with a minimum of 50% marks with Chemistry as one of the subject from JKBOSE or from any other recognized board.</i>
B. Sc. Zoology	<i>Having passed 10+2 science subjects with a minimum of 50% marks from JKBOSE or from any other recognized board.</i>
B. A. Economics	<i>Having passed 10+2 with a minimum of 50% marks from the J&K Board of School Education or from any other recognized board.</i>
B. A. English	<i>Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board.</i>
B. A. Political Science	<i>Having passed 10+2 with a minimum of 45% marks from the JKBOSE or from any other recognized board.</i>
B. A. Journalism & Mass Communication	<i>Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board.</i>
B. A. Islamic Studies	<i>Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board.</i>
B. A. Arabic Language & Literature	<i>Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board OR Madrasa passouts possessing Aalimiyah, Fazeelah or Aaliyah alongwith 10th class certificate from JKBOSE or from any other recognized board. (All educational qualifications and degrees must be obtained in chronological order).</i>

5-Year Integrated Programmes	Eligibility
Integrated BBA-MBA	Having passed 10+2 with a minimum of 50% marks from the J&K Board of School Education or from any other recognized board.
Other Undergraduate Programmes	Eligibility
B. Tech. Food Technology	Having passed 10+2 from the J&K Board of School Education or from any other recognized board with Physics, Chemistry & Mathematics or Biology as compulsory subjects.
B. Voc. Tourism and Hospitality Management	Having passed 10+2 with a minimum of 45% marks from the J&K Board of School Education or from any other recognized board.
B. Arch.	Having passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with either Chemistry or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Engineering Graphics or Business Studies with at least 45% marks in aggregate OR Passed 10+3 Year Diploma Examination with Mathematics as compulsory subject with at least 45% marks in aggregate. AND The candidate should have qualified an aptitude test in Architecture conducted either by NTA (i.e. JEE Paper 2A) or "NATA" conducted by the Council of Architecture.

Note: Candidates having passed 3-Year Engineering Diploma (at par with NCrF Level IV) are also eligible for admission to the above programmes.

II) SUBMISSION OF ONLINE APPLICATION FORMS:

The candidates are advised to follow the below mentioned steps for filling the details in their On-line Application Form:

- Visit the University website www.iust.ac.in, click the link **Admissions 2026** and register as a new user/ login.
- Enter the details as per your Matriculation Certificate and verify the phone number/ email id by entering the verification code sent on your registered phone number. Note your login id for future reference, the same shall also reflect in your registered email id.
- Before filling the Online Application Form, please read instructions carefully and keep the required documents ready for online uploading (wherever applicable).
- Click on "Apply Online" tab and choose appropriate option "Apply for Undergraduate Programme" as per your eligibility.
- Complete all the below mentioned 07 (seven) steps:

- iv. *Choose Programme (s) for Admissions.*
- v. *Upload Documents (The documents to be uploaded must be in the format of .jpg, .jpeg, .png or .pdf, between size 100-200 kb).*
- vi. *Preview/ Submit & Make Online Payment. (Before clicking Submit & Make Payment check again if all the details/ documents are entered/ uploaded correctly, as it cannot be changed or modified after the final submission & fee deposition. An acknowledgement message will be generated and sent to your registered email id/phone no. on successfully deposition of application fee).*
- vii. *Download the submitted Application Form (Candidates need **not** to submit the hard copy of the downloaded Application Form; however, they must keep the softcopy of the downloaded application form for future reference and records).*

III) PROCEDURE FOR SELECTION:

In supersession of all previous notices regarding the selection procedure, the revised criteria are as follows:"

- **FYUGP/ 5-Year Integrated/ Other Undergraduate Programmes:** *The selection shall be made on the basis of qualifying examination (12th) percentage.*
- **B. Arch:** *The selection shall be based on qualified candidate's performance in the NATA/ JEE (Paper-2A) 2026. However, first preference shall be given to NATA-2026 Candidates.*

IV) IMPORTANT NOTES:

- Admission Guidelines 2026 can be viewed/ downloaded from the University website: www.iust.ac.in.
- The application fee is **Rs. 500/-** (non-refundable). In case candidates apply for more than one programme, they shall have to pay an additional fee of **Rs. 200/-** per programme (non-refundable) through Online mode only.
- The candidature of the candidates who do not possess eligibility criteria notified shall be rejected without any notice.
- Make judicious use of web service, in case of any immoral/ irrelevant content is uploaded on online application form, strict action under rules will be initiated by the university.
- The candidates are advised to check the Application Form Status by using the same login id and password and clicking on tab "Application Form Status".
- The candidature of applicants who fail to submit all the required documents/ prescribed application fee shall be rejected.
- During the registration period, University may entertain corrections in the details submitted as well as change in preferences or any other update when communicated on admissions@iust.ac.in during the said period. No change will be accepted through offline mode i.e. through fax/application etc.
- The eligible meritorious candidates with weak economic background can apply for admission under the Economically Weaker Section (EWS)/ Tuition Fee Waiver (TFW) scheme. The terms & conditions are reflected in the Admission guidelines 2026.
