**Subject: Conduct of the 2<sup>nd</sup> Round of Counselling/Submission of Online Preferences by the eligible candidates for admission to 12th-Based Paramedical Courses-2025.**

## **Notification No. 084-BOPEE of 2025 Dated 30-07-2025**

Pursuant to Notification No. 070-BOPEE of 2025 dated 05-07-2024, the Board has received a shortfall from various Government/Private Colleges/Institutions of the UT of J&K. To fill up these shortfall seats along with the seats which have become available due to non-joining and non-willingness for upgradation, resignation/surrender or remain vacant during first round of counselling, it is hereby notified for information of all concerned candidates that the Board shall conduct the Second Round of Online (Upgradation/Allotment) counselling w.e.f. **31-07-2025 to 03-08-2025**.

The following candidates shall be eligible to participate in the Second Round of Online (Upgradation/Allotment) Counselling:

1. Candidates who did not get any seat in the first round.
2. Candidates who have been allotted a seat during the first round and have joined the College/Institute and have submitted their willingness for upgradation on the JK BOPEE portal.
3. Candidates who have been allotted a seat during the first round and have not joined the College/Institution but have submitted their willingness for upgradation on the JK BOPEE portal.
4. Candidates who have been allotted a seat during the First Round but could not join due to any of the reasons, like deficient/invalid documents, non-submission of fee, non-reporting for admission, etc., but have submitted their willingness for upgradation.
5. Candidates who have resigned by or before the last date of admission of the allotted seat of First Round at the College/Institution.
6. The eligible candidates who have qualified for the Entrance Test of 12th-Based Paramedical Courses-2025 and have not participated during the First Round of counselling are also eligible for this round of counselling. They are required to pay the online counselling fee of Rs. 1000/- and fill in the preferences for the 2<sup>nd</sup> Round of Counselling.

### **Important Note:**

1. The preferences indicated by the candidates during the first round of counselling shall be deemed to be cancelled and shall not be applicable for 2<sup>nd</sup> round of counselling. The candidates have to submit fresh preferences for the 2<sup>nd</sup> round of counselling. If a candidate does not submit fresh

choices/preferences during the choice-filling period, the candidate will not be considered for allotment of a seat during 2<sup>nd</sup> round and will retain the already joined seat, if any.

2. In this round, only vacant seats shall be filled from respective categories as per where shortfall has been received, i.e. **the seats left out by the OM candidates during the 1<sup>st</sup> round shall be allotted to the OM candidates, and those left by the category candidates shall be allotted to the category candidates based on merit-cum-preferences.**
3. The candidates who have paid the online fee during the 1<sup>st</sup> Round shall not be required to pay any fee during this round of counselling.

The seat matrix shall be uploaded separately as per the schedule referred above, and all the participating/eligible candidates are advised to go through the seat matrix before participating in the counselling process.

The other terms and conditions shall remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard.
