While going through the records, it has come to notice that the registration of Ph.D scholars as per Annexure -I has either already expired or is going to be expired soon. As per the Ph.D Ordinance, registration of a Ph.D scholar is valid for a period of 6 years.

In case a scholar fails to submit his/her thesis within the stipulated period of 6 years he/she will have to re-register for the programme provided that the scholar has completed 80% and above of research work (60% in case of women candidates and persons with disability) as per the guidelines.

The re-registration cases of such scholars is to be recommended by the Departmental Research Committee (DRC) & forwarded to Dean Research Office at least 03 months prior to the expiry of the registration period and their re-registration needs to be approved by Board of Research Studies (BORS) or Hon'ble Vice Chancellor in anticipation to BORS.

In view of the above, you are as such requested to favor your remarks including the justifications for the delay in applying for the re-registration. This information will enable this office to proceed further in the matter.
