NOTICE

Whereas, various non-teaching positions including the post of Assistant Registrar were advertisement by the University vide Advertisement Notice No. 05 of 2017 dated: 05-05-2017.

Whereas, the application forms were scrutinized by the Screening Committee constituted for the purposed and final screening report of candidates for the post of Assistant Registrar has been notified vide No. IUST/Reg/Adm/18/E/1015 dated: 16-05-2018.

Whereas, various representations were received from some candidates requesting to re-examine their candidature/eligibility as per the final screening report in view of the documents produced by them.

Whereas, the representations along with documents submitted by the candidates were forwarded to concerned screening committee to re-examine the cases.

Whereas, the screening committee re-examined the cases as detailed below, in view of the documents submitted by the candidates along with their representations and declared the eligibility of such candidates as under:

Whereas, no change is warranted in the status of eligibility of candidates above at S.No 1 – 4 as recommended by the Screening Committee. However, the committee declared the candidate above at S.No. 05 namely Azeem Bashir bearing Application Form No. 1210196 as eligible for the said post who had applied/submitted the application form including requisite fee for the post of Assistant Registrar advertised vide advertisement notice No. 02 of 2015 dated: 22/01/2015 under application No. 510010 and had also applied a fresh application through online mode in response to advertisement notice No. 05 of 2017 dated: 05-05-2018. The Committee also found that the said candidate has completed all the formalities of applications as per the instructions laid down in the advertisement notice no. 05 of 2017 dated: 05-05-2017 besides fulfilling the eligibility criteria as required for the said post.

Now, therefore, in view of the above, it is hereby notified for information all concerned candidates that the candidature of the candidate namely **Azeem Bashir S/o Bashir Ahmad Shah R/o Amnoo Kulgam bearing application form No. 1210196** has been incorporated in the final screening report for the post of Assistant Registrar as an eligible candidate.
