Essential Qualification:

 B.Tech/ B.E. in Information Technology/ Computer Science Engineering/ Electronics and Communication Engineering from a recognized University with alteast 55% marks or equivalent GPA.

Or

MCA/ M.Sc. Information Technology with at least 55% marks or equivalent GPA from a recognized University

2. Three years of experience in software development on e-governance system in a University Education System / Research Institute.
