#### **GENERAL TERMS AND CONDITIONS/ INSTRUCTIONS.**

- 1. The terms and conditions governing the service shall be as per the University Statutes with amendments from time to time.
- 2. Candidates must enter the relevant API score in the 3Performance Based Appraisal System (PBAS) Proforma. Each API score must be supported by the documentary evidence, without which no claim on account of API Score will be entertained. It is mandatory that the candidate mark Page No./s on all the supporting documents as in the Application Form. The details with regard to ISSN/ISBN, sole author/Coauthors/Joint publication, refereed/non-refereed/indexed/non-indexed and local/national/international status/impact factor etc. must also be reflected in the publication part of PBAS proforma supported by documentary evidence. In case the candidate remains silent on any information, it shall be deemed that he / she does not want to claim it.
- 3. The time taken by candidates to acquire M.Phil and /or Ph.D degree shall not be considered as teaching / research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment.
