 mode of application will be accepted.
- 2. The candidates are required to pay the non refundable fee of Rs. 1000/- (Rupees One Thousand only) with the application through online mode by debit card/ credit card/ net banking.
- 3. Hard copy of application form complete in all respects duly supported by attested copies of all relevant documents, certificates and testimonials is mandatory to be submitted in the office of Registrar by or before the last date of submission of hardcopies of the application forms, failing which the online application form submitted by the candidates shall not be considered. Applications received after the expiry of the due date will not be entertained.
- 4. The terms and conditions governing the service shall be as per the University Statutes with amendments from time to time.
- 5. The candidates in employment (Govt. or Semi Govt.)on substantive position or otherwise should forward their applications through their employer.
