

1. The Temporary engagement is purely on need basis Academic Arrangement for the Academic Session 2022 ending on 31-12-2022. This engagement shall stand terminated by efflux of time on stipulated date or till the posts are filled on substantive basis whichever occurs first.
2. The temporary faculty shall have to submit an Affidavit as per the prescribed format on Rs. 100/- stamp paper duly notarized for the period from his/ her date of joining.
3. In case the performance and conduct or student feedback is found unsatisfactory, the engagement shall be discontinued immediately at any time without giving any notice.
4. The temporary faculty shall be bound to act in conformity with the Statutes, Ordinances, Regulations and rules of the University as well as a code of professional ethics as may be formulated by the INC/UGC/AICTE/MHRD.
5. If any information / document furnished or declaration / undertaking given is found false / incorrect including breach of undertaking so given as terms agreed hereto, the same shall render him/her liable towards criminal/ civil liability for such incorrect / false / perverse statement / document including termination of his/her services with immediate effect.
6. In case the Tutor intends to resign he/she shall have to give one month's advance notice in writing or forfeit one month's salary in lieu thereof.
7. The concerned contractual Tutor shall join within seven days from the date of issuance of this order, failing which the order shall be issued in favour of the next candidate(s) in order of merit.
