Online applications for the post of Registrar (37400-67000 with GP of Rs. 10,000/-) are invited from the residents of J&K having following qualifications:-

- i) Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC 7-point scale'.
- ii) At least 15 years of experience as Assistant Professor in the AGP of Rs.7000 and above or with 8 years of service in the AGP of Rs. 8000 and above including as Associate Professor along with experience in educational administration. **or**
- iii) Comparable experience in research establishment and/or other institutions of higher education, or
- iv) 15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

<u>Desirable</u>: Published work on University Administration and experience in handling administration / legal / financial / establishment matters.

<u>Job profile</u>: Registrar is expected to deal with the university administration, keep records of the university, maintain liaison with faculty and staff. He will also perform such of the duties as have been specified in the University Act, Statutes, Ordinances, Rules and Regulations as may be required by the Statutory Bodies and the Vice-chancellor.

Candidates serving in the Government/Semi government or a University fulfilling the above criteria and desirous to serve IUST on deputation basis can also apply. Such candidates shall have to submit an NOC from the current employer for applying for the post alongwith a certificate that the incumbent shall be relieved under rules to serve the IUST in case of selection.

Recently retired candidates who fulfill the above criteria can also apply and may be considered for appointment on contractual basis.

- 1. Deputation/Contract shall initially be for a period of three years extendable upto five years based on performance or till the age of 65 years whichever is earlier.
