#### **Eligibility Criteria:**

- 1. The firm should be registered in J&K.
- 2. Valid PAN& Goods Service Tax Registration with appropriate license to run the service.

Interested firms/agencies/vendors may submit their Expression of Interest (EOI) to the Registrar, Islamic University of Science & Technology, Awantipora-192122 with a non refundable fee of Rs. 5000/- in the form of demand draft favouring "Islamic University of Science & Technology," which should reach to him by or before 17<sup>th</sup> of August 2017 by 4.00 pm.

The University reserves the right to accept or reject any Expression of interest without assigning any reason there off.

#### **Terms and Conditions:**

- 1. The vehicles should be brand new.
- 2. The firm/companies/Vendor must have the valid ownership certificate of the vehicles to be provided for the purpose
- 3. The firm has to provide the required transportation facility for approximately 800 students.
- 4. The vehicles should have proper registration, fitness certificates, comprehensive insurance certificates and required route permits.
- 5. All the taxes related to the vehicles/transportation services/pollution free certificates as per J&K Motor Vehicles rules must be cleared.
- 6. The Drivers of the vehicles should have valid driving license.
- 7. Firm/vendor should provide adequate vehicle staff in order to maintain discipline and provide safety and un-interrupted transportation service.
- 8. All the disputes arising related to Transportation service is purely the responsibility of the firm/vendor.
- 9. The parking of the buses shall be the responsibility of the service provider.
- 10. The buses shall leave and reach to the University as per the timings notified by the University from time to time.
- 11. In case of any breakdown of the vehicle, the substitute arrangement shall be made available to the route within half hour with no additional cost to the University.
- 12. The drivers shall follow the rules and regulations of the University with regard to the transport.
- 13. The busses offered should carry the name of the University on the body.

Expression of interest (EOI) form downloaded from the University website should be accompanied with a non refundable processing fee of Rs 5000 (Rupees Five Thousand Only) in the form of demand draft in favour of Islamic University of science & Technology. In case of non submission of the fee, the EOI shall be summarily rejected.
