## **Terms and Conditions**

- > The amount shall be released in 2 instalments. The first instalment will be 100% of the non-recurring expenditure and 50% of the recurring expenditure. There shall be a mid-term evaluation to monitor the progress after six months of this letter. You are expected to submit UC's well in time of the evaluation committee meeting which shall be communicated to you in advance. Depending upon the utilization of funds and the progress of the project remaining grants will be released.
- > The project is expected to give rise to a publication in an internationally reputed Journal (with good impact factor wherever applicable) or a book published by a reputed publishing house or a policy document which would be accepted by the State Govt. or any other agency for implementation. This shall be considered as an Indicator of successful implementation of the project. In case of the failure of producing the desired publication and as determined by the Evaluation Committee the project can be deemed as a failure and the concerned researcher(s) shall be barred from research grants for a period of three years.
- > The amount released shall have to be spent according to the approved heads/items within the approved allocation as per the details annexed.
- Decisions regarding the progress, release of grants and the final status of the project shall be taken by the Evaluation Committee and shall be binding on all concerned.
- The purchase/procurement of different items and honorarium to experts under the project shall be undertaken as per the existing norms of the University.
