Subject: The Ramanujan Fellowship award to Dr. Rais Ahmad Ganai, Central University of Kashmir, Nowgam-II, Newar Puhroo Chowk, Nowgam Bye pass, Srinagar - 190015, J & K - Release of first installment.

- Sanction of the SERB is also accorded to the payment of Rs.21,80,000/- (Rupees Twenty-one lake eighty thousand only) ring being the grant for the year 2018-19 for implementation of the above said fellowship.
- 3. a) If the host institute is providing free accommodation, no House Rent Allowance (HRA) is admissible
- and same need to be refunded to SERB.

  b) If the host institute is deducting HRA and license fee for the accommodation provided, then the same may be recovered from the HRA being paid to the fellow. However, reimbursement shall be limited to the HRA being paid by SERB. Excess recovery, if any, has to be made by the host institute directly from the fellow.
- The expenditure involved is debitable to Fund for Science & Engineering Research (FSER). This release is being made under Ramanujan fellowship.
- 5. Sanction of the grant is subject to the condition as detailed in Terms & Conditions available at website (www.serb.gov.in) and as per Ramanujan fellowship guidelines.
- Overhead expenses are meant for the host institute towards the cost for providing infrastructural facilities and general administrative support etc., including benefits to the staff employed in the fellowship.
- 7. The institute will maintain separate audited accounts for the project. It is advisable to keep a part or whole of the grant in an interest earning bank account. The interest thus earned should be reported to SERB and will be treated as a credit to the institute to be adjusted towards further instalment of grant.
- 8. As per rule 211 of GFR, the accounts of fellowship shall be open to inspection by sanctioning authority/audit whenever the institute is called upon to do so.
