Sanction of **Anusandhan National Research Foundation (ANRF)** is hereby accorded to the above mentioned fellowship under the **Science and Engineering Research Board (SERB)** scheme - **National Post Doctoral Fellowship (N-PDF)** at a total cost of **Rs. 26,73,600/- (Rs. Rupees Twenty Six Lakh Seventy Three Thousand Six Hundred only Only)** for a duration of 24 months. The date of start of the fellowship is effective from the date of joining in the host institute .
The items of expenditure for which the total allocation of **Rs. 26,73,600/-** has been approved are given below:

Sanction of the **ANRF** is also accorded to the payment of **Rs. 13,36,800/-** (Rupees Thirteen Lakh Thirty Six Thousand Eight Hundred only) under 'Grants-in-aid General' to **Islamic University Of Science & Technology University, 1-University Avenue, Awantipora** being the first installment of the grant for the year 2024-2025 for implementation of the said research project.

3. The expenditure involved is debitable to **Science & Engineering Research Fund**
This release is being made under National Post Doctoral Fellowship (N-PDF). (Chemical Sciences)

4. The Sanction has been issued to with the approval of the competent authority vide Diary No. **ANRF/F/1706/2024-2025** dated **18 May, 2024**

5. Sanction of the grant is subject to the conditions as detailed in Terms & Conditions available at website (www.serb.gov.in).

6. Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc. including benefits to the staff employed in the project.

- 9.The institute will furnish Utilization certificate (UCs) financial year wise to the ANRF and an audited statement of accounts pertaining to the grant immediately after the end of each financial year.
10. The institute will maintain separate audited accounts for the fellowship. A part or whole of the grant must be kept in an interest earning bank account which is to be reported to ANRF. The budget head-wise interest thus earned will have to be returned to the ANRF by way of a Demand Draft/account-payee cheque drawn in favour of the "Science & Engineering Research Fund", payable at New Delhi and sent to the DDO/US, ANRF along with a copy of UC/SE.
11. The File no. **PDF/2023/003725** may also be mentioned in all research communications arising from the above project with due acknowledgement of **ANRF**.
12. As this is the first grant for the fellowship, no previous U/C is required.
13. The institute must refund any unspent balance to ANRF by means of a Demand Draft favouring "**SCIENCE AND ENGINEERING RESEARCH FUND**" payable at New Delhi.
