## **Hospital Internship**

The B.Voc. course in Medical Lab & Molecular Diagnostic Technology involves internship training in a professional laboratory setting at a tertiary care hospital. As part of the skill development, students must undergo hospital internship every semester. The hospital internship is critical for students to integrate the theory learned in a classroom with the actual daily duties and requirements of a medical technology professional. Students get exposed to the Standard Operation Procedures (SOPs) of clinical laboratories and diagnostic centers. During the internship period, students get to work under the supervision of a senior professional laboratory technician in conducting laboratory tests, procedures, experiments, and analysis to provide data for diagnosis, treatment, and prevention of disease. They analyze bodily fluids, tissue samples, and microbiology samples to determine the presence of normal and abnormal components.
