

In compliance with NEP 2020 whereby high stakes examination have been discouraged, Academic Council in the interest of holistic learning and with a focus on incorporation of formative assessments, has directed as under: -

- I. In courses where viva exams form part of each semester, concerned departments in consultation with the Examination Section shall develop continuous assessment framework in lieu thereof.
- II. For constitution of Evaluation Panel, wherever applicable, concerned departments shall submit a panel of Faculty/experts from within IUST only.
- III. For project evaluation part in courses where Projects form part of the Course, Examination Section shall frame assessment proforma after seeking inputs from departments wherever deemed necessary, which among other things shall give weightage to timely submission of the project reports to facilitate timely completion of Degrees. Further, departments shall ensure finalization of projects before the end of Penultimate Semesters; wherever, not feasible for any reason, department shall have to justify.


